ARTICLES OF INCORPORATION
OF

Article I


Article X



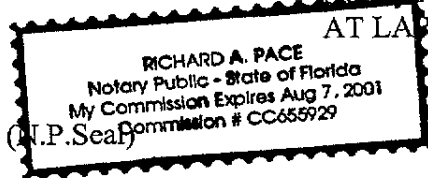


