In compliance with the requirements of The Florida Business Corporation Act, the undersigned act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a corporation.

ARTICLE I

The name of the corporation ("Corporation") is Robin's Flowers, Inc.

ARTICLE II

The existence of the Corporation shall begin on September 15, 1999.

ARTICLE III

The street address of the principal office of the Corporation is 204 East Martin Luther King Boulevard, Tampa, Florida 33603.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred (100), par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 204 East Martin Luther King Boulevard, Tampa, Florida 33603. The initial registered agent for the Corporation at that address is Robin Green.

ARTICLE IV




The Corporation shall indemnify its directors, officers and employees to the fullest extent permitted by law.
