ARTICLES OF INCORPORATION OF VISTA DEL MAR PROPERTIES, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the Laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is VISTA DEL MAR PROPERTIES, INC.
