The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be JOHN DeBICKES AND ASSOCIATES, INC.

ARTICLE II

Principal Office

Corporate Purposes, Power and Rights
