The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is **Russia.Com Inc.** The principal place of business of this Corporation shall be 18309 Cypress Stand Circle, Tampa, FL 33647, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue Twenty Million (20,000,000) shares of common stock, no par value.
