

Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **Ray's Electric, Inc.**, and the initial corporate address is 2011 West 15th Street, Panama City, Florida 32401.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having no par value.

Article IV. Term of Existence

This corporation shall have perpetual existence commencing upon filing of the articles.

Article V. Registered Agent and Initial Registered Office






