CERTIFICATE OF INCORPORATION

<u>ARTICLE I - NAME</u>

The name of this corporation shall be:

777 Shops, Inc.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States or of this State.

ARTICLE III - CAPITAL STOCK

ARTICLE V - TERM OF EXISTENCE

This corporation shall have a perpetual existence.
