ARTICLES OF INCORPORATION  
OF

ARTICLE I  
NAME

The name of the corporation is: MOGERMAN, O'LEARY & PATEL II, INC. at 701 N.W. 19 St., #100, Ft. Lauderdale, FL 33311,

ARTICLE II  
DURATION

This corporation shall have perpetual existence.

ARTICLE III  
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


