ARTICLES OF INCORPORATION
OF
C M & M C. Inc.

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contact, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be CM & MC, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.

ARTICLE III - PURPOSE

The general purpose for which the corporation is organized are :

1. To transfer any lawful business for which corporation may be incorporated under the Florida Corporation Act, and
2. To do such things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV - CAPITAL STOCK

A. The maximum number of shares that this corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1000) shares of common stock having ONE DOLLAR (\$1.00) par value, which may be fractional shares.

B. All or any portion of the capitol stock may be issued in payment for real or personal property, services or any other right or things having a value in the judgment of the board of directors, at least equivalent to the full value of the stock so to be issued as herein above set forth, and when so issued shall become a fully paid and nonassessable, the same though paid for in cash; and the directors shall be the sole judges of the value of any property, right or things acquired in exchange for capitol stock, and their judgment of such value shall be conclusive.

C. Notwithstanding the foregoing, the corporation shall have the right to increase it's capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualifications or voting powers, of such additional stock, in an amendment to its Certificate of Incorporation.

ARTICLES V - Initial Registered Office and Agent
