ARTICLES OF INCORPORATION

RAVEN WORKZ, INC.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be Raven Workz, Inc.

ARTICLE II - PURPOSE
