ANTON CONCEPTS, INC. 2005 ANNUAL REPORT

Anton Concepts, Inc. Articles of Incorporation were filed on September 15, 1999 and assigned document number P99000083106.

The principal place of business and mailing address is 521 N. Riverside Dr., Apt. 905, Pompano Beach, 33062. The corporation is authorized to have 6 outstanding shares of stock at any one time.

Anton Breznikar, 521 N. Riverside Dr., Apt. 905, Pompano Beach, Fl. 33062 is the current registered agent. The incorporator to these Articles of Incorporation is Anton Breznikar, 521 N. Riverside Dr., Apt. 905, Pompano Beach, Fl. 33062. The principal business of this corporation is home improvements. Anton Breznikar serves as President/VP and Loretta Breznikar serves as Secretary/Treasurer.

On November 8, 1999 notice of acceptance as an S-Corporation with an accounting period of December was accepted. The election effective beginning January 1, 2000.

The Department of the Treasury, Internal Revenue Service, Atlanta, G. 39901, assigned EIM 65-0948071 open notice dated 9/24/99 to Anton Concepts, Inc.

During the year of 2005, no salaries were paid to the officers or labor paid to the president for his services but health and life insurance were paid. A loan for tools in the amount of \$179.14, a loan for a life insurance payment in the amount of \$514.59 and a loan for \$1100 in August, 2005 was made to the corporation by Anton and Loretta Breznikar, totaling \$1793.73. At the end of 2004 loans made to the corporation by Anton and Loretta Breznikar totaled \$12,325.51. The amount from 2004 and 2005 totaled \$14,119.24. During 2005, the corporation was able to make payments of \$13,900 against these loans, leaving a balance of \$219.24 for the year 2006.

Another large job has been bid and is expected to increase revenues for 2006.

The annual meeting date was changed from April 1, 2006 to April 8, 2006.

The financial statement reports gross receipts of \$55,571.22, interest paid to Wachovia Bank in the amount of \$566.40, less expenses of \$55,933.15, and depreciation taken for the Ford Econo Van in the amount of \$6,846.08 with a net loss of \$7,774.41. A non deductible expense of \$900.68 was shown. A Schedule K1 was issued to Anton Breznikar showing a loss of \$7,774.41.

Analysis of Accumulated Adjustments Account shows a balance at the beginning of tax year of (\$16,250.75), loss of \$7,774.41 for 2005, leaving a balance at the end of the tax year of (\$24,025.16)
