The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

The name of this corporation is:

ARTICLE II – PRINCIPAL OFFICE

ARTICLE VII – INITIAL BOARD OF DIRECTORS

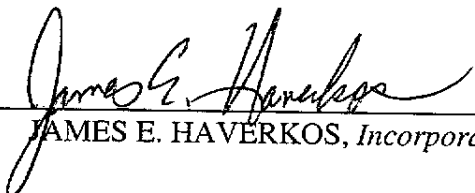

ARTICLE IX – INDEMNIFICATION

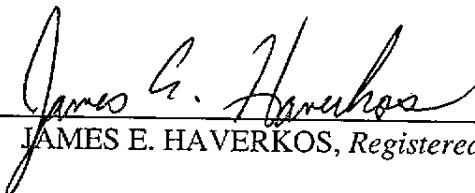
The corporation shall indemnify all officers and directors, and former offices and directors, to the full extent permitted by law as the law now exists or may be amended hereafter.
