Prior to June 14, 2002 the corporate office for 704 Second Street was at 1975 East Sunrise Boulevard, Suite 625A, Fort Lauderdale, Florida 33304.

On December 26, 2001 new management was hired to run the building located at 1975 East Sunrise Boulevard, where we had our corporate office. Due to new management, many things changed in the building which included mail delivery problems, telephone line problems and elevator problems.

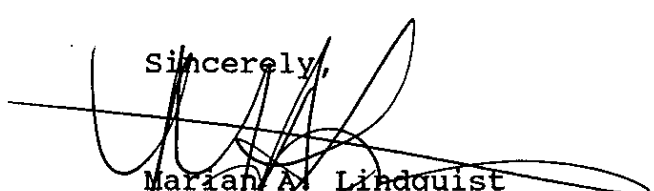
