

Dear Sir or Madam:

I am writing in response to your request for the 2001 Uniform Business Report that was not filed prior to May 1, 2001. Floorplay, Inc. is a newly established corporation that my husband and I work very hard at operating according to the guidelines set forth by your division. However, since receiving your second request for this report we have had to go back and research what could have happened to the first report that he and I were both positive that we filed in a timely manner at the beginning of the year. Unfortunately, during the first half of this year I became ill and had to undergo several surgeries. Therefore, I had to relinquish much of my responsibilities and we hired someone to come in to help with the paperwork. After things began to turn up missing we were forced to let her go. My husband and I are certain that we filled out and signed the first request for the report and instructed her to mail it along with a check. She later called him and stated it had to be paid in a money order and he left her the cash to purchase one. Although your form clearly states to pay with a check, I had handled the paperwork up until this point so he did not question this. We believed the money order was never purchased and the first report was discarded. We learned a very hard lesson in those six months and are grateful that the damage done was minimal, with the exception of the failure to file this report. We would never knowingly do or not do something that could result in dissolution or revocation of the corporation we have worked so hard to establish. I contacted your office at the number listed and was instructed to include this letter of explanation along with a check for \$150.00 and we would be notified if it is possible for the late fee to be waived or if it is still due. We understand that the responsibility is ultimately ours as the business owners to insure that the company is run properly in accordance with the rules of the state and ignorance or misfortune on our part is no excuse. We are willing to comply with whatever decision you reach on this matter. I wanted to explain the circumstances though in case there was a chance the late penalty could be reduced or waived in this case. Again, we apologize for any inconvenience this delay may have caused.
