ARTICLES OF INCORPORATION OF VIENNA ANTIQUES OF SOUTH FLORIDA INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida, U.S.A.

ARTICLE I

NAME: The name of this corporation shall be:

VIENNA ANTIQUES OF SOUTH FLORIDA INC.

ARTICLE II

PURPOSE AND POWERS: The general nature of the business to be transacted by the corporation is as follows: RETAIL SALE OF EUROPEAN ANTIQUES, SCULPTURES AND ART.
