#### ARTICLE I

NAME: The name of this Corporation is MILECO, INC., and its address is Post Office Box 790, Zellwood, Florida 32798.

#### ARTICLE II

DURATION: This Corporation shall exist perpetually.

#### ARTICLE III

#### ARTICLE IV


