ARTICLES OF INCORPORATION OF REGGAE GRILLE, INC.

The undersigned acting as the incorporators of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation as follows:

ARTICLE I NAME

The name of the corporation is REGGAE GRILLE, INC. (hereinafter called the "Corporation").

ARTICLE II DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

ARTICLE III PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV CAPITAL STOCK

The Corporation is organized to have outstanding one class of stock designated as common stock. The maximum number of shares of common stock which the Corporation is authorized to have outstanding is 100 shares of common stock at \$1.00 par value per share. Holders of common stock are entitled to vote on all questions required by law on the basis of one vote per person and there shall be no cumulative voting. Holders of common stock shall not have preemptive rights to subscribe to the Corporation's securities.

ARTICLE V INITIAL PRINCIPAL OFFICE

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office and agent of this Corporation is 14450 Southwest 161st Street, Miami, Florida 33177. The name of the Corporation's initial registered agent at that office is: April Parchment-Knight.

ARTICLE VII INITIAL BOARD OF DIRECTORS

The street address of the initial board of directors of this Corporation is 14450 Southwest 161st Street, Miami, Florida 33177. The name of individuals who are to serve as the initial board of directors of the Corporation are: Seymour Knight and April Parchment-Knight.

VIII <u>BY</u> LAWS

ARTICLE X AMENDMENT

This Corporation reserves the right to amend or repeal any prior provisions contained in these Articles of Incorporation or any amendment thereto.
