ARTICLES OF INCORPORATION

OF

IVANHO FOOD ENTERPRISES OF BAYSIDE III, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I Corporate name

The name of the corporation is Ivanho Food Enterprises of Bayside III, Inc., hereinafter referred to as the "Corporation."
