We filed our Uniform Business Report on 4-25-00 along with a \$150.00 check. The check was cashed and we believed the form was filed. However, we received another form to fill out in September. We did not receive it until almost the due date September 13. Since we had already filed and our check had been cashed we thought the second form was a mistake. Recently, in a conversation with the Department of Revenue, about sales taxes, we were informed that there was a problem with our corporate status due to our FEIN. We called your office and were informed that our corporation had been dissolved due to an inaccurate FEIN. We were also informed that your office had sent us a letter about this. We never received this letter. We did have a problem with our mail being delivered to Gardenview Rd., instead of our address Garden View St.. This problem is probably the reason the second form was received late. We have recently changed address (shown on enclosed form) to remedy this problem. We were also told to check with the IRS to confirm our FEIN. We have and it is valid.
