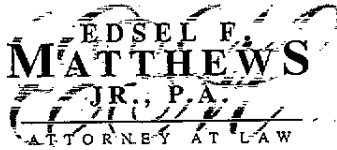

The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I - NAME & ADDRESS

The name of this corporation is CommServices, Inc., and the address of the corporation is 115 East Garden Street, Pensacola, Florida 32501.

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these articles of incorporation.

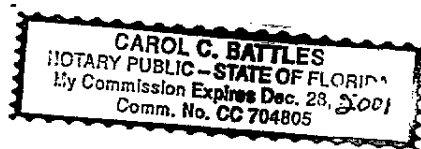

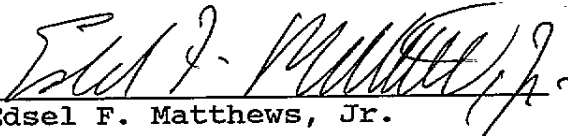
