

ARTICLE I - NAME



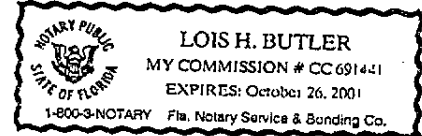
