
ARTICLE IX



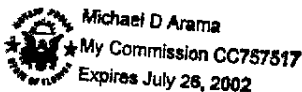


