ARTICLES OF INCORPORATION

OF

ANGELS' HOUSE ALF, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be ANGELS' HOUSE ALF, INC.

ARTICLE II - PURPOSES
