

**ARTICLES OF INCORPORATION
OF
DOYLE DEAN LOGISTICS, INC.**

Article I - Corporate Name

The name of this corporation is **DOYLE DEAN LOGISTICS, INC.**

Article II - Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III - Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of one dollar (\$1.00) per share.

Article IV - Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles.

Article V - Registered Agent and Initial Registered Office

The Registered Agent and the street address of the initial Registered Office of this Corporation in the State of Florida shall be Luther M. Taylor, 11911 U.S. Highway One, North Palm Beach, FL 33408.


Article IX - Incorporator

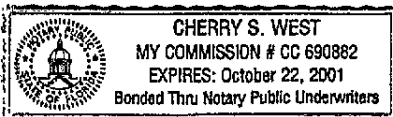


