ARTICLES OF INCORPORATION

OF

SAC-I, INC.

The undersigned hereby organizes a corporation for profit under the provisions of the Flori Business Corporation Act, and pursuant to the following Articles of Incorporation.

ARTICLE 1

<u>Name</u>

ARTICLE 2
