ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is T & C Flooring, Inc.
- 2 TERM. This corporation shall exist perpetually.
- 3. <u>PURPOSE</u>. The purpose of this corporation is to conduct any lawful business.
