I, the undersigned, do hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of incorporating Accurate Hearing Aid Center, Inc., (the "Corporation"), under the Laws of the State of Florida.

## ARTICLE I

NAME - The name of the Corporation is: Accurate Hearing Aid Center, Inc.

## **ARTICLE II**

PRINCIPAL OFFICE AND MAILING ADDRESS - The Corporation's principal office shall be located at 4175 Fifth Avenue North, St. Petersburg, Florida 33713, and its mailing address shall be the same.

## ARTICLE III

TERM OF EXISTENCE - The Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

### ARTICLE IV

The Board of Directors may move the Registered Office to any other address in the State of Florida.

## ARTICLE VII
