ARTICLES OF INCORPOTATION OF Rubal & Yern Investments, Inc.

ARTICLE I-NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Rubal & Yern Investments, Inc. and its principal mailing address is 3072 Bird Avenue, Miami, FL 33133.

ARTICLE II- DURATION

This Corporation is to exist perpetually. It shall commence upon the signing of these Articles of Incorporation by the Incorporator.

ARTICLE III- PURPOSE

This Corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States of America and the laws of State of Florida.

ARTCLE IV - CAPITAL STOCK
