ARTICLES OF INCORPORATION  
Of  
DEPENDABLE MARBLE COMPANY

KNOW ALL MEN BU THESE PRESENTS: That the undersigned subscriber to these Article of Incorporation, a natural person, of full age, competent to contract, hereby desires to form a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I: NAME

The name of this corporation shall be DEPENDABLE MARBLE COMPANY.

ARTICLE II: GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in the general building of structures and all fixtures and attachments relating to or connected thereto, including but not limited to manufacturing, fabricating, repairing, transporting, erecting, demolishing, financing, selling, buying, encumbering, financing, mortgaging any and all of the foregoing without limitation and every legal business permitted under the laws of the State of Florida.

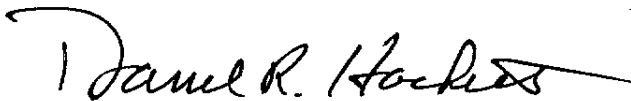
