The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

Article I - Name

The name of the corporation is Taxi's Pizza Two, Inc. The principal office of the corporation is 2229 Joan Avenue, Panama City, Florida 32407, and the mailing address is P. O. Box 2222, Panama City, Florida 32402.

Article II - Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

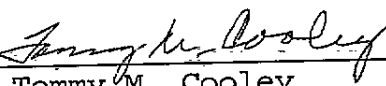
