ARTICLES OF INCORPORATION

OF

The undersigned JUSTIN G. JOSEPH does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The names of this corporation shall be TAMPA BAY TIE-DOWN SERVICES, INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted shall be mobile home tie down inspection and installation.

The corporation is organized for the purpose of transacting any and all other lawful business and is organized to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE III

CAPITAL STOCK

OFFICERS OF THE CORPORATION


The officers of the corporation shall be DAVID P. FOLKENFLIK, President/Secretary; and PAUL CHAMLEY, Vice President/Treasurer.






