ARTICLES OF INCORPORATION
OF
QUINCY HOME CENTER, INC.

I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of this corporation shall be *QUINCY HOME CENTER, INC.*

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation shall be 1853 West Jefferson Street, Quincy, Florida 32351.

ARTICLE III

Term of Existence

The duration of this corporation shall be perpetual. This corporation begins its corporate existence the same date as the filing of these Articles of Incorporation with the Florida Department of State.

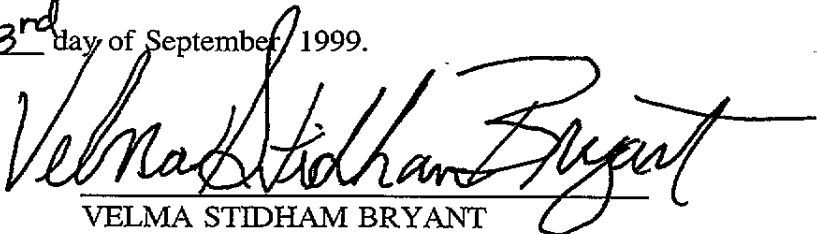
