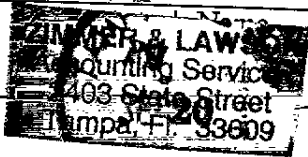

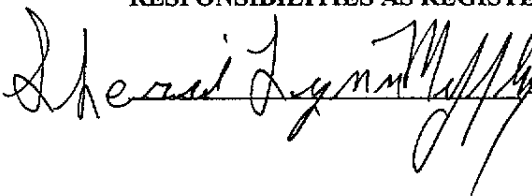

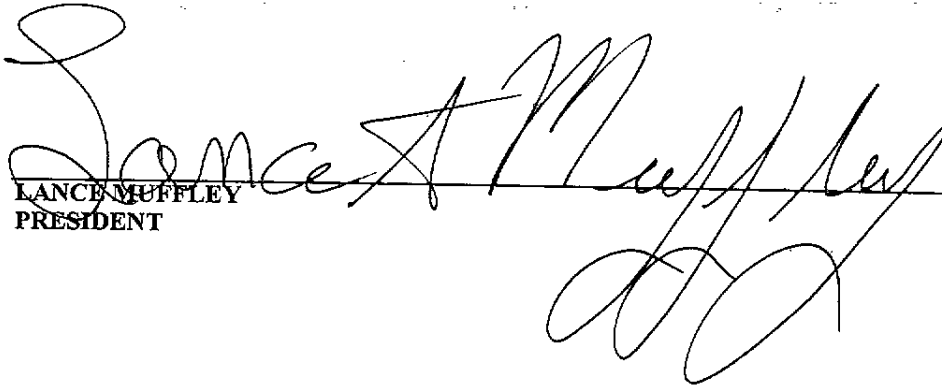
#### ARTICLE XI
