ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Rusiness Corporation Act, hereby adopts the following Articles of Incorporation.

# PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 11930 Lark Song Loop, Riverview, Florida, 33569.

# ARTICLE III SHARES
