Enclosed is the year 2000 UBR on behalf of the referenced corporation together with a check payable to the order of the Department of State in the amount of \$150.00. For the reasons that follow, it is respectfully requested that the increase in filing fee for late filing be waived and that the enclosed payment be accepted in full payment of the year 2000 fee.

For reasons unknown, a pre-printed 2000 UBR was not received from the Division of Corporations. The undersigned therefore requested a "replacement" UBR by telephone from the Division of Corporations on or about April 28, 2000. This form was completed upon its receipt and forwarded to the sole officer and director of the corporation, who was in Vienna, Austria at the time. The properly executed UBR was not received back until July 20, 2000.

Again, please accept the enclosed check in full payment of the corporation's 2000 filing fees. The untimely filing of the year 2000 UBR and payment of the annual filing fees was due primarily to the inaccessibility of the only person authorized by statute to sign the UBR and not intentional disregard of the filing requirements.
