OF

The undersigned, acting as sole incorporator, does hereby desire to form a corporation for profit pursuant to the Florida Business Corporation Act and does hereby adopt the following Articles of Incorporation:

Article I- Name of Corporation

The name of the corporation shall be **WESTSHORE MANAGEMENT, INC.**

Article II - Term of Existence

The corporation shall commence its corporate existence upon the _____ of these Articles of Incorporation and shall perpetually. _____ incorporation

Article III - General Purposes

The general purposes for which the corporation is organized shall be to manufacture, construct, purchase, or otherwise acquire, dispose of, and to invest in trade in, trade in, and deal in and with Products, goods, wares, merchandise, real and personal property and services of every kind, class, and description. The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by the Florida Business Corporation Act.

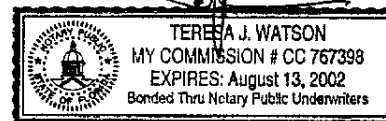
