To whom it may concern:

Actual Publishing Inc was defrauded by four individuals working within the nation's security system. They used NSA technology to override the clear commerce module attached to my corporate bank account and processed through my website "The Belly of the Beast" dotcom.

Furthermore, their crimes have been reported to the FBI and the Parkland Police Department.

PJ dotnet= apic APIC=INTERLAND. N-S-A dotcom uses INTERLAND as its server. I can tie all of these suspects to National Security directly. All of them have their cyber-prints on my website and sales.

I am relieved I saw Robert Mueller's testimony as it frees me from the more sensitive disclosures necessary to prove my case. My evidence is IRREFUTABLE!

Once again I understand the need for discretion. However, I don't understand the need to incarcerate or assassinate an American citizen for catching criminals that happen to work for the Federal Government.
