**ARTICLES OF INCORPORATION
OF

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME AND ADDRESS OF CORPORATION

The name of the corporation shall be Fed Tyme Records, Inc. The address of the corporation shall be 4 East Plant Street, Winter Garden, FL 34787.

ARTICLE II-TERM OF EXISTENCE

This corporation shall exist perpetually.


ARTICLE VIII-AMENDMENT TO ARTICLES

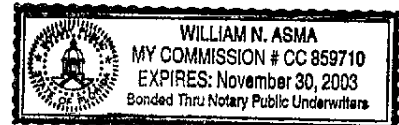
