

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, residents and citizens of the United States of America, of full age of majority, for the purpose of forming a for-profit corporation pursuant to the Florida Business Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation shall be MAINSTREAM COMMUNITY DEVELOPMENT CORPORATION OF MIAMI, INC.

**ARTICLE II**


