ARTICLES OF INCORPORATION

OF

MARITIME & MARINE SERVICES, INC.

By these Articles of Incorporation, the undersigned Subscriber forms a corporation in accordance with Chapter 6075 Florida Statutes, and pursuant to the following provisions ("Articles"):

ARTICLE I

NAME

The name of the corporation shall be Maritime & Marine Services, Inc., and, for convenience, shall be referred to in this instrument as the "Corporation".

ARTICLE II

DURATION

The Corporation shall exist perpetually unless and until dissolved according to law. Corporate existence of the Corporation shall commence upon the filing of these Articles with the Florida Department of State.

ARTICLE III

PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the initial principal office of the Corporation and the Corporation's mailing address is 4770 Willow Bend Drive, Melbourne, Florida 32935.

ARTICLE IV

REGISTERED OFFICE AND AGENT

ARTICLE V

PURPOSES AND POWERS OF THE CORPORATION

The purposes of the Corporation shall be to engage in the business of providing maritime and marine consulting services, and any and all other lawful purposes. The Corporation shall have the power and duty to do any and all lawful things which may be

ARTICLE IX

Such officers, directors, committee members and employees shall not be liable for any mistake of

judgment, negligent or otherwise, except for their own individual willful misfeasance, malfeasance, misconduct, or bad faith. The officers and directors of the Corporation shall have no personal liability with respect to any contract or other commitment made by them, in good faith, on behalf of the Corporation (except to the extent that such contract or commitment may specifically provide otherwise), and the Corporation shall indemnify and forever hold each such officer and director free and harmless against any and all liability to others on account of any such contract or commitment. Any right to indemnification provided for herein shall not be exclusive of any other rights to which any officer, director, committee member, or employee, or former officer, director, committee member or employee may be entitled.
