

### ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under E. FLORIDA the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

#### Article I Name

The name of the corporation shall be JEEVES ENTERPRISES, INC.

#### Article II Principal Office

The principal place of business of this corporation shall be 25 Vista Garden Trail Apt. #104, Vero Beach, Florida 32962.

## Article III Purpose: Nature of Business
