

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is DELRAY WINE SELLER, INC.,

ARTICLE II - PRINCIPAL OFFICE/MAILING ADDRESS

The principal office and the mailing address of this corporation is 4630 Sunrise Blvd., Delray Beach, FL 33445.

ARTICLE III - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to issue is ONE THOUSAND (1,000), which shares shall be common stock having a one dollar (\$1.00) par value.

ARTICLE XII - AMENDMENT


