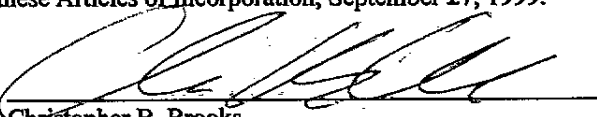
**ARTICLE VII**

The corporation shall exist perpetually or until terminated by law. Cherry Hill Aviation, Inc. exists for the purpose of conducting any lawful business.

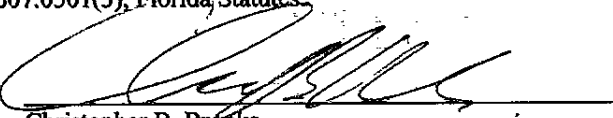
**ARTICLE VIII**
