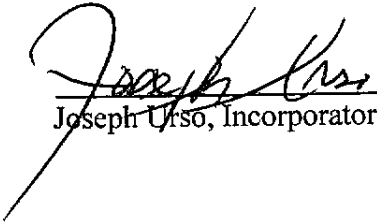
ARTICLE VII: EFFECTIVE DATE

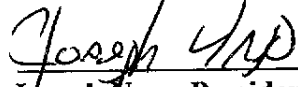
