The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of becoming a professional corporation in accordance with Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act.

The Name of this corporation shall be

MOHAN PERSAUD, MD, PA

The corporation is to have perpetual existence.

The corporation is organized as a Professional Service Corporation as permitted under the Florida Statutes and the Corporation will be engaged in every aspect of the business of rendering professional services to the public that a Medical Doctor, duly licensed under the laws of the State of Florida, is authorized to render. This Corporation may engage in or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

The maximum number of shares which the corporation shall have the authority to issue shall be SIXTY (60), all of which shall be common stock without par value.




