To Whom It May Concern:

I am writing in regard to my 2001 UBR filing for Sail Tiki Incorporated, document number P99000085351. There has been a problem with my mail pickup and delivery at my old address, 3830 NE Indian River Drive, Jensen Beach, Florida, 34957. I never personally received a 2001 UBR form at that address, and in fact I have not received any correspondence from the Department of State since I changed my address this past March.

My corporation, though officially active, has not been "in business" yet, and has not made one dollar of income. I have tried to file all forms and pay all fees to keep things current with your offices. I travel extensively, and often mail must be forwarded to me around the country. If any UBR reports have been sent to my registered business address, I have not received them. Speaking to an adviser in your offices August 28, 2001, a Miss K. Whited, I was informed that these UBR forms would not be forwarded to me should I be elsewhere.

When I spoke to an accountant (the day before I spoke to Miss Whited), he asked me about filing the UBR. I told him that I had not, and that I thought his offices dealt with those matters for me. Of course I was very upset when he told me the form had not been filed and that there was a \$400 -penalty for not filing by the original due date! Basically, until a week or two ago, I was completely unaware that the UBR was unpaid and delinquent! This is why I am writing to you today.

I always try my best to pay bills and to file fees in a timely manner, yet with an inactive business and extensive travel there has been very little dealing with such matters for the last few months. Sail Tiki is, in fact, inactive as far as sales tax collections are concerned. I file my fees with your department simply to keep the name of the corporation and the fictitious name current and in my possession.

Miss Whited sent me, via mail; the UBR form I enclose now. She also suggested that I write a letter to you and to submit a check for the original amount due of \$150. I sent the enclosures via express mail to assure their timely delivery. I apologize for any inconvenience, and there have now been several issues resolved regarding my mail and the misunderstandings of filing these reports. I assure you that this will never happen again, and I thank you for your time and consideration.
