Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

TEWARI A/C MAINTENANCE & REPAIR, INC.

ARTICLE II

The purpose for which this corporation is organized is to engage in AC service, maintenance & repairs and its field of specialization.

ARTICLE III
