*To Whom It May Concern:*


*I, as president of The Abraham Group, Inc. ("Corporation"), the general partner of the Partnership, request that you waive the delinquency penalty for the late filing of both the Partnership's and Corporation's annual report based on reasonable cause and good faith.*

*To begin with, all of the limited partners of the Partnership and shareholders of the Corporation are Canadian citizens and are unfamiliar with the annual filing requirements. In Canada, once we form an entity or corporation, there are no annual filing requirements thereafter. Further, neither the Partnership nor the general partner remember receiving any notice to file the annual report. However, since receiving notice from you that our Partnership and the Corporation have been administratively dissolved, we have taken appropriate steps to get both entities reinstated and, more importantly, have learned of the importance of the annual filing requirements. From hereon, both the Partnership and Corporation shall timely file and pay the annual report and fees. Therefore, based on the foregoing, I request that the Department of State waive the late filing penalty and accept our enclosed reinstatement forms and payments of \$604 for the Partnership and \$238.75 for the Corporation.*
