#### ARTICLES OF INCORPORATION

OF

### RICHARD A GRIFFIN, O.D., P.A.



The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of optometry in the State of Florida, hereby associates himself with the intention of forming a Professional Service Corporation and hereby adopts the following Articles of Incorporation.

#### ARTICLE I: Name

The name of this corporation is Richard A. Griffin, O.D., P.A.

#### ARTICLE II: Purpose

This corporation is organized for the following purposes:

- A. To engage in the practice of optometry as a professional corporation and to carry on services incident thereto,
- B. To own property, enter into contracts and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this Corporation.
- C. The professional services of the Corporation shall be carried out only through officers, employees and agents authorized by law to render such services.

# ARTICLE III: Capital Stock

The total number of shares of capital stock which the Corporation shall be authorized is one thousand (1,000) shares. Such shares shall be a single class of common stock and shall have a par value of ONE DOLLAR (\$1.00) per share.

# ARTICLE IV: Capitalization

The amount of capital with which the Corporation will begin to practice the profession of optometry is not less than ONE HUNDRED DOLLARS (\$100.00).S.

## ARTICLE XIII: Effective Date
