ARTICLE I - NAME

The name of this corporation is **ADVANCED GRAPHICS OF TAMPA
BAY INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the following
purposes:

To engage in any activity or business permitted



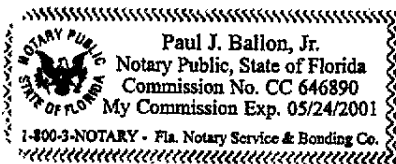
